

# Why a Quebec Court Case Matters so Much

he Evangelical Fellowship of Canada stood before the Supreme Court of Canada on May 18 in defence of the parental right to decide on education — particularly the religious education — of their children.

In 2008, the Quebec government introduced the controversial Ethics and Religion and Culture (ERC) program as mandatory in all schools. With the goal of teaching "harmonious social relations," the grade one to 11 program instructs on the place of religion — Catholicism, Protestantism, Judaism, Native Spiritualism, etc — in Quebec's history. While there may be good intent, the development of a curriculum that regards all religions as equal and without distinct and true claims on the life of believers provides an unbalanced view. The program also regards ethics arising from a communal or conversational and situational basis, without regard for religious claims of absolute truth being foundational in both belief and practice.

The ERC has been criticized by secularists for imposing instruction on religion — and by people in the faith community for imposing inaccurate instruction about religious beliefs and practices. In short, the ERC does not recognize the legitimacy of the sincerely held religious beliefs of Christians — or any other faith community.

Although the program is not a requirement for graduation, every student is compelled by law to attend, without exception. This applies to public schools, private schools, religious schools, and home schooling.

Some evangelical parents have noted the benefit of having the place of religious contribution to the development of Quebec society recognized. Others are greatly concerned about the impact, on their children, of parental authority on religious instruction challenged by the authority of the teacher. "The right to pass on one's religious and cultural heritage to their children is a fundamental aspect of religious freedom and parental authority in Canada," noted Faye Sonier, EFC legal counsel.

In addition to parental concern, several teachers are concerned that they are required to teach the program which inaccurately depicts their personal faith and does not permit them to teach from that faith perspective.

"The goal of the ERC – to develop 'attitudes of tolerance, respect and openness' in order to prepare children 'to live in a pluralist and democratic society' – is betrayed by the very lack of tolerance, respect and openness to pluralism and democracy that is demonstrated in the curriculum itself, and by the Government of Quebec's approach to mandatory instruction," said Don Hutchinson, EFC's general legal counsel.

SPOTLIGHT: Canadian Network of Ministries to Muslims (CNMM), an EFC Ministry Partnership

An interview with Randy Hoffman, chair of the CNMM

# What is the most important thing we need to know about the Canadian Network of Ministries to Muslims (CNMM) partnership?

This is a comprehensive network that is open to all denominations, organizations and ministries across Canada, and our focus is Canada. The CNMM works to mobilize the Church to bear witness to the gospel to people of Islamic faith. The Muslim world is diverse with 4000 different people groups. We have a significant number of Muslim groups here in Canada and generally they know little of the Christian faith and of the gospel. They are becoming our neighbours.



# How can this partnership help Evangelicals better engage with their own communities?

There are many misunderstandings about Islam. Churches can use this network to be better informed about Islam, how to develop relationships of care with their Muslim neighbours, and how to talk about our Christian faith. Churches in general have been slow in learning how to make meaningful connections. Learning how to build relationships needs to take place. That is a role that we believe this network, made up of individuals from different churches and organizations, can fill. For example, churches do camp ministry in the summer. In some of these camps Muslim kids are coming. But the camp personnel don't know how to address the Islamic backgrounds of these kids. Same for the Muslim women who go to church-run crisis pregnancy centres looking for help. When churches engage in social service activities and encounter Muslims, CNMM can help with training and resources. We know where to get literature and other inexpensive resources. At our national conference in Calgary last year we offered DVDs and large numbers of books with materials about understanding Muslims, and how to talk about our faith.



# What new initiatives are around the corner? What should we be watching for from this partnership?

We're continuing to set up more city networks across Canada. Right now we are in 10 cities, and that number will grow. A network is made up of a leader working with a group of people from various denominations and ministries. Muslim background believers are part of the CNMM. We're continuing to put things in place so the Church across Canada can be resourced, empowered and strengthened to share the gospel in word and deed with our Muslim neighbours. The CNMM/EFC is organizing a national conference in Toronto in Oct. 2012 with workshops, networking, resources and plenary speaker George Verwer, founder of Operation Mobilisation. All are welcome to attend. We want the ministry to be owned by local churches or organizations. We are here to help them.

# Office of Religious Freedom: An EFC Goal for Canada Realized

When Stephen Harper pledged to create an Office of Religious
Freedom in Canada during the recent election campaign it was
the realization of a long-standing EFC goal. The EFC has been a rigorous
advocate for the formation of an Office of Religious Freedom in Canada through our
Centre for Faith and Public Life in Ottawa and the EFC Religious Liberty Commission.

Christians are the most persecuted people in the world — 176,000 Christians were killed for their faith from mid-2008 to mid-2009. Prime Minister Harper pointed to three tasks of the new office: to monitor religious freedom around the world; to promote religious freedom as a key objective of Canadian foreign policy; and to advance policies and programs that support religious freedom around the world.

The EFC believes that this office will form a critical part of Canada's foreign policy. The EFC anticipates the office will work closely with Canadian faith communities and organizations with expertise in this area. The EFC is poised to help.
